6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 25-11-2024 14:00 at the office of Tila Rural Municipality Raralihi Jumla Karnali Province Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
